- Sure, the rate has not increased since 1981. Of course not. It is a percentage! The government's take has already gone way up as inflation has raised the price of a room. Now, they want to raise the percentage, and then, want that percentage to go up even more, automatically.
- So the Transient Occupancy Tax has no impact on Foster City residents? Really? What 2 about AirBnb? The law specifically defines that "hotels" includes "apartment houses", "mobile not homes", just about anything people could sleep in. (If you dare host renters in your home, be recareful. The penalties for violating this law are up to 6 months in jail!)
- Proponents argue that other cities have similar taxes. And yes, they want those taxes increased, too. Everybody will pay more and more as they tax each other, everybody paying taxes they cannot vote on.
- These taxes are just wrong. Tax the visitors? Tax your guests? Tax anybody but by yourselves? Don't tax a mansion; tax sharing a condo? Don't tax the rich; tax the homeless camily in a motel? How disgraceful.
