WHEREAS, an additional appropriation for \$80,000 is necessary for the Levee Protection Planning and Improvements Project (CIP 301-657) budget.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Foster City does hereby:

- Authorize the Mayor to execute an agreement with Kitahata & Company and William Euphrat Municipal Finance, Inc. in the amount not-to-exceed \$80,000 to provide an evaluation of financing options and to implement a financing strategy of debt financing for the Levee Protection Planning and Improvements Project (CIP 301-657), and
- 2. Approve the appropriation of \$80,000 from the City Capital Projects Fund for the Levee Protection Planning and Improvements Project (CIP 301-657).
